RESOLUTION AUTHORIZING HON. ATTY. PEDRO A. SURDILLA, JR., MUNICIPAL VICE MAYOR AND PRESIDING OFFICER AND MRS. MARILOU M. GAVINO, LOCAL REVENUE COLLECTION OFFICER III, SG-18, DESIGNATED ACTING MUNICIPAL TREASURER, TO BE THE OFFICIAL AND AUTHORIZED SIGNATORIES FOR ALL DEPOSITS AND OTHER RELATED BANK TRANSACTIONS AT THE LAND BANK OF THE PHILIPPINES (LBP) DAGUPAN CITY BRANCH ON ALL EXPENDITURES APPROPRIATED FOR THE OPERATION OF THE SANGGUNIANG BAYAN AND THE OFFICE OF THE SANGGUNIANG BAYAN SECRETARY OF THE LOCAL GOVERNMENT UNIT OF MANGALDAN, PANGASINAN EFFECTIVE MARCH 30, 2021.

WHEREAS, an endorsement obtain from the Office of the Municipal Mayor calling for the passage of a resolution authorizing Mrs. Marilou M. Gavino, Local Revenue Collection Officer III, SG-18, designated Acting Municipal Treasurer, as one of the official and authorized signatories in all financial transactions including bank institutions of the Municipality effective March 30, 2021;

WHEREAS, the Land Bank of the Philippines (LBP) Dagupan City Branch is one of the depository banks of the Local Government Unit of Mangaldan, Pangasinan;

WHEREAS, Section 445 (I) of the Local Government Code of 1991 mandates that the Vice Mayor shall be the presiding officer of the Sangguniang Bayan and shall sign all warrants drawn on the Municipal Treasury on all expenditures appropriated for the operation of the Sangguniang Bayan;

WHEREAS, the Municipal Vice Mayor/Presiding Officer being the head of the local legislative department is authorized to sign all vouchers, all checks/warrants for all expenditures appropriated under the Office of the Sangguniang Bayan including the Sangguniang Bayan Secretariat;

WHEREFORE, on motion of Councilor Atty. Fernando Juan A. Cabrera duly seconded by all other members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan authorizes Hon. Atty. Pedro A. Surdilla, Jr., Municipal Vice Mayor and Presiding Officer and Mrs. Marilou M. Gavino, Local Revenue Collection Officer III, SG-18, designated Acting Municipal Treasurer, to be the official and authorized signatories for all deposits and other related bank transactions at the Land Bank of the Philippines (LBP) Dagupan City Branch on all expenditures appropriated for the operation of the Sangguniang Bayan and the Office of the Sangguniang Bayan Secretary of the Local Government Unit of Mangaldan, Pangasinan effective March 30, 2021;


