18, DESIGNATED ACTING MUNICIPAL TREASURER, TO  
BE THE OFFICIAL AND AUTHORIZED SIGNATORIES OF  
ALL BANK/BUSINESS TRANSACTIONS OF THE LOCAL  
GOVERNMENT UNIT OF MANGALDAN, PANGASINAN AT  
THE LAND BANK OF THE PHILLIPINES (LBP)  
MANGALDAN BRANCH, THE DEPOSITORY BANK OF THE  
LGU EFFECTIVE MARCH 30, 2021.

WHEREAS, an endorsement obtain by the Sangguniang Bayan from the

the depository bank of the Local Government Unit of Mangaldan, Pangasinan;

WHEREAS, as provided for by the pertinent provisions of R.A. 7160 of the Local Government Code requires, the Local Government Units must designate and authorize the new set of signatories in all and any Depository and Lending Institutions servicing the LGU for the smooth and proper governance of the LGU and its inhabitants;

WHEREAS, the Sangguniang Bayan is empowered by the Local Government Code of 1991 to authorize the Municipal Mayor, the Municipal Vice Mayor and the Municipal Treasurer as signatories for all bank/business transactions;


