
RESOLUTION NO. 2021 – 83

RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. MARY MARILYN DG. LAMBINO, TO ACCEPT ONE (1) UNIT OF MOTORCYCLE (COMPLETE SET) FROM HOME IDEAS SUPERSTORE, THROUGH MR> PAUL FRANCIS CO TO BE USED BY THE PHILIPPINE NATIONAL POLICE PERSONNEL OF THE LOCAL GOVERNMENT UNIT OF MANGALDAN, PANGASINAN.

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code, states that, “Every Local Government Unit shall exercise the powers expressly granted those necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”;

WHEREAS, one of the primary programs of the Municipality is to discharge its functions and responsibilities to promote peace and order to the public and deliver basic services to its constituents;

WHEREAS, the Municipality of Mangaldan has to cater thirty (30) barangays with a projected population of 115,000 by the year 2021;



WHEREAS, the Local Government Unit of Mangaldan, Pangasinan has to its record numerous motor vehicles and equipment which are being used in the delivery of basic services to the people. Nevertheless, these facilities are not yet enough to satisfy the transportation requirement of a certain LGU in order to respond to a speedy delivery of basic communication and other services relative thereto;

WHEREAS, the Municipality of Mangaldan is fortunate enough to have establishments with generous stakeholders whom are sensitive to the needs of the LGU that accepted them to run their business;


