RESOLUTION NO. <u>2020 – 109</u>

RESOLUTION REQUESTING HON. MAYOR MARY MARILYN DG. LAMBINO TO EXTEND THE MORATORIUM ON THE COLLECTION OF MONTHLY RENTALS FOR STALLS AT THE PUBLIC MARKET SHUTTERED DURING THE ENHANCED COMMUNITY QUARANTINE (ECQ) AS A RESULT OF THE COVID-19 EPIDEMIC UNTIL THE ECQ SHALL HAVE BEEN LIFTED BY THE NATIONAL GOVERNMENT.

WHEREAS, on March 20, 2020, the Sangguniang Bayan of Mangaldan passed and approved Resolution No. 2020-70, RE: Resolution calling for a Moratorium on the Collection of Monthly Rentals for Stalls at the Public Market shuttered during the Enhanced Community Quarantine as a result of the COVID-19 epidemic which is supposed to last until April, 2020;

WHEREAS, the Enhanced Community Quarantine has been extended until May 15, 2020 without any assurance that our situation will totally return its normal condition;

WHEREAS, the provisions of the Enhance Community Quarantine remain to be in forced and effect, thus the non-essential businesses are to be continuously

shuttered so as to comply with the order of the national government. Ostensibly, these stall owners will continuously experience income losses;

WHEREAS, the Sangguniang Bayan of Mangaldan reiterates its plea that in the interest of justice, they are appealing to the good heart of the Honorable Mayor Mary Marilyn DG. Lambino to continuously forego the payments of rents during the extended period of the Enhanced Community Quarantine from April, 2020 until the said ECQ shall have been lifted by the National Government;

WHEREFORE, on motion of Councilor Atty. Joseph Emmanuel B. Cera and duly seconded by all the remaining members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan requests Hon. Mayor Mary Marilyn DG. Lambino to extend the Moratorium on the Collection of Monthly Rentals for Stalls at the Public Market shuttered during the Enhanced Community Quarantine (ECQ) as a result of the COVID-19 Epidemic until the ECQ shall have been lifted by the National Government;
