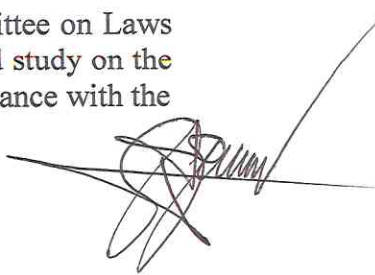
RESOLUTION NO. 2020 – 115

RESOLUTION DECLARING THE SUPPLEMENTAL BUDGET
NO. 1 FOR CY 2020 OF BARANGAY OSIEM, MANGALDAN,
PANGASINAN INVOLVING A TOTAL APPROPRIATION OF
ONE HUNDRED FIFTY THOUSAND PESOS (P150,000.00)
OPERATIVE IN ITS ENTIRETY.

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local
Government Code of 1991, the Sangguniang Bayan of Mangaldan as a Legislative

submitted Supplemental Annual Investment Program of the Barangay pursuant to the noble intention of the Sangguniang Kabataan of the said Barangay;

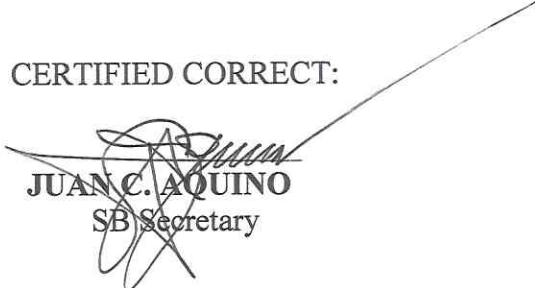

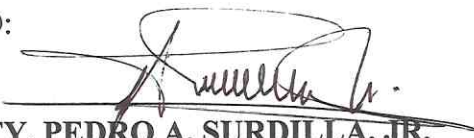
