
RESOLUTION NO. 2020 – 118

RESOLUTION APPROVING RESOLUTION NO. 02, SERIES
OF 2020 OF THE SANGGUNIANG BARANGAY OF
GUEGUESANGEN, MANGALDAN, PANGASINAN,
ENTITLED “APPROVING AND ADOPTING THE
SUPPLEMENTAL ANNUAL INVESTMENT PLAN (AIP) NO.
1, CY 2020 OF BARANGAY GUEGUESANGEN,
MANGALDAN, PANGASINAN.

WHEREAS, the Sangguniang Barangay of Gueguesangen, Mangaldan,
Pangasinan submitted its Resolution No. 02 to the Sangguniang Bayan for review
and evaluation pursuant to Section 57 of R.A. No. 7160, otherwise known as the
Local Government Code of 1991;

WHEREAS, the said Supplemental Annual Investment Program is a
product of the noble gesture of the Sangguniang Kabataan of Barangay
Gueguesangen, Mangaldan, Pangasinan as they have thought of realigning some
portion of their 10% share from the Annual Barangay Budget to involve their
Sangguniang Kabataan Council in the fight against COVID-19;

WHEREAS, the Committee on Appropriation and the Committee on Laws
and Ordinances made an initial review and study on the said resolution and found



out that the same was in order. Accordingly, despite the fact that the said resolution did not pass through the Local Finance Committee for technical review, the said the Committee on Appropriation and the Committee on Laws and Ordinances of the Sangguniang Bayan deemed it fine to approve the resolution taking into consideration the nobility of the programs, projects and activities of the Sangguniang Kabataan and the urgency and needs for its immediate implementation in view of the onslaught of COVID -19;

WHEREFORE, on joint motion of Councilor Atty. Joseph Emmanuel B. Cera and Councilor Atty. Fernando Juan A. Cabrera duly seconded by the remaining members present:


