## RESOLUTION NO. <u>2020 – 119</u>

RESOLUTION DECLARING THE SUPPLEMENTAL BUDGET NO. 2 FOR CY 2020 OF BARANGAY GUEGUESANGEN, MANGALDAN, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF ONE HUNDRED EIGHTY THOUSAND PESOS (P186,000.00) OPERATIVE IN ITS ENTIRETY.
