RESOLUTION NO. 2020 – 125

RESOLUTION DECLARING THE SUPPLEMENTAL BUDGET
NO. 1 FOR CY 2020 OF BARANGAY NIBALIW,
MANGALDAN, PANGASINAN INVOLVING A TOTAL
APPROPRIATION OF NINETY THOUSAND PESOS

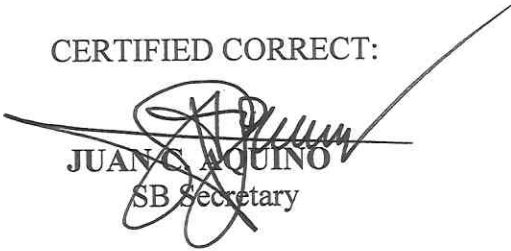

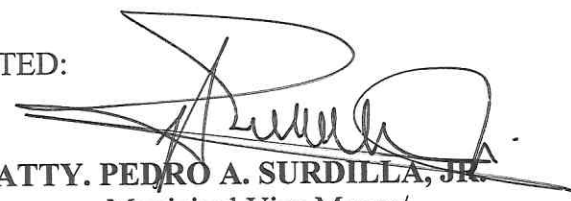
