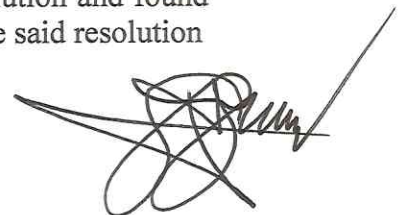
RESOLUTION NO. 2020 – 128

RESOLUTION APPROVING RESOLUTION NO. 03, SERIES OF 2020 OF THE SANGGUNIANG BARANGAY OF BATENG, MANGALDAN, PANGASINAN, ENTITLED “APPROVING AND ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN (AIP) NO. 1, CY 2020 OF BARANGAY BATENG, MANGALDAN, PANGASINAN.

WHEREAS, the Sangguniang Barangay of Bateng, Mangaldan, Pangasinan submitted its Resolution No. 03, Series of 2020 to the Sangguniang Bayan for review and evaluation pursuant to Section 57 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the said Supplemental Annual Investment Program is a product of the noble gesture of the Sangguniang Kabataan of Barangay Bateng, Mangaldan, Pangasinan as they have thought of realigning some portion of their 10% share from the Annual Barangay Budget to involve their Sangguniang Kabataan Council in the fight against COVID-19;

WHEREAS, the Committee on Appropriation and the Committee on Laws and Ordinances made an initial review and study on the said resolution and found out that the same was in order. Accordingly, despite the fact that the said resolution

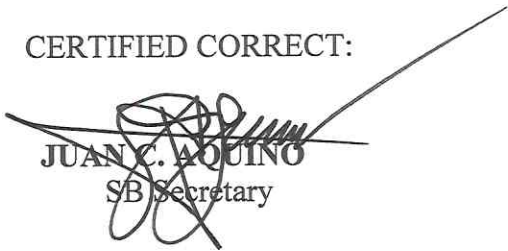

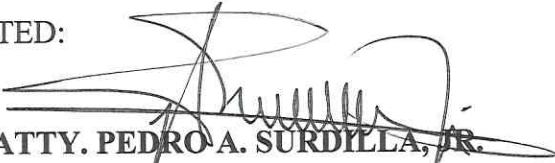
