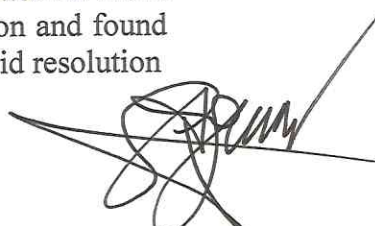
RESOLUTION NO. 2020 – 130

RESOLUTION APPROVING RESOLUTION NO. 01, SERIES

AND ADOPTING THE SUPPLEMENTAL ANNUAL
INVESTMENT PLAN (AIP) NO. 1, CY 2020 OF BARANGAY
SALAAN, MANGALDAN, PANGASINAN.

WHEREAS, the Sangguniang Barangay of Salaan, Mangaldan, Pangasinan
submitted its Resolution No. 01, Series of 2020 to the Sangguniang Bayan for
review and evaluation pursuant to Section 57 of R.A. No. 7160, otherwise known
as the Local Government Code of 1991;

WHEREAS, the said Supplemental Annual Investment Program is a

Mangaldan, Pangasinan as they have thought of realigning some portion of their
10% share from the Annual Barangay Budget to involve their Sangguniang

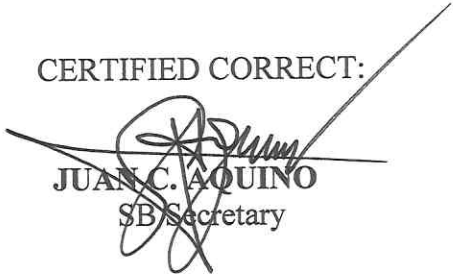

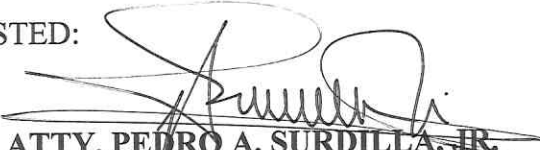
