RESOLUTION NO. 2020 – 136

RESOLUTION STRONGLY RECOMMENDING TO THE OFFICE OF THE MUNICIPAL MAYOR THE IMMEDIATE STANDSTILL OF THE CONSTRUCTION OF A CELLULAR TOWER IN BARANGAY BARI, MANGALDAN, PANGASINAN.

WHEREAS, a considerable number of concerned or maybe affected residents of Barangay Bari wrote a Petition Letter addressed to the Office of the Municipal Mayor and Sangguniang Bayan of Mangaldan, RE: Petition to Stop the Construction of a Cellular Tower in Brgy. Bari, Mangaldan Pangasinan;

WHEREAS, it was alleged among others that the Contractor of the Cellular Tower being built in Barangay Bari recklessly continuing the construction of the Tower despite objection of these concerned citizens who cares for their health, notwithstanding the fact further that there was a province-wide declaration of extreme enhanced community quarantine;

WHEREAS, Section 447, par. a, (4) provides for the regulations of activities to the use of lands, building and structures within the municipality in order to promote the general welfare. Further, (5) sub. par. (ix) Regulate the placing, stringing, attaching, installing, repair and construction of all gas mains,

electric, telegraph and telephone wire, conduits, meters and other apparatus; and provide corrections, condemnation or removal of the same when found to be dangerous, defective or otherwise hazardous to the welfare of the inhabitants;

WHEREAS, it is an innate obligation of the Local Administration to protect the interest and welfare of its people pursuant to the provision of Section 16 of R.A. 7160, otherwise known as the Local Government Code of 1991 which provides: **Section 16. General Welfare.** - Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants”;

WHEREAS, finding the Petition in order and complete in substance and form, the Sangguniang Bayan of Mangaldan deemed it proper and appropriate to listen to the cry of our constituents in barangay Bari, Mangaldan, Pangasinan;

WHEREFORE, on motion duly seconded by all the remaining members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan strongly recommends to the Office of the Municipal Mayor the immediate standstill of the construction of a Cellular Tower in Barangay Bari, Mangaldan, Pangasinan;

RESOLVED FURTHER, that copies of this resolution be furnished the Sangguniang Barangay of Bari through Punong Barangay Arnolfo A. Muyano, the MLGOO, Mrs. Romarie P. Soriano, the Commission on Audit through Mrs. Marina P. De Guzman, Audit Team Leader, the Office of the Municipal Mayor, Hon. Mary Marilyn DG. Lambino and all other authorities concerned for their information and favorable action.


