#### RESOLUTION NO. <u>2020 – 146</u>

RESOLUTION DECLARING THE SUPPLEMENTAL BUDGET NO. 01 FOR CY 2020 OF BARANGAY GUILIG, MANGALDAN, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF ONE HUNDRED THOUSAND PESOS (P100,000.00) OPERATIVE IN ITS ENTIRETY.

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Bayan of Mangaldan as a Legislative Body of the Municipality is empowered to review Ordinances authorizing annual or supplemental appropriations of Barangays in the manner prescribed by law;

WHEREAS, the Barangay Council of Guilig, Mangaldan, Pangasinan has submitted its Supplemental Budget No. 01 for CY 2020 involving a total appropriation of One Hundred Thousand Pesos (P100,000.00) which was approved on May 2, 2020 through Appropriation Ordinance No. 1, Series of 2020;

WHEREAS, the Committee on Appropriation and the Committee on Laws and Ordinances of the Sangguniang Bayan made an initial review and study on the said resolution and found out that the same was in order and in consonance with the submitted Supplemental Annual Investment Program of the Barangay pursuant to the noble intention of the Sangguniang Kabataan of the said Barangay;

WHEREFORE, on joint motion of Councilor Atty. Joseph Emmanuel B. Cera and Councilor Atty. Fernando Juan A. Cabrera duly seconded by the remaining members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan declares the Supplemental Budget No. 01 for CY 2020 of Barangay Guilig, Mangaldan, Pangasinan involving a total appropriation of One Hundred Thousand Pesos (P100,000.00) operative in its entirety;
