RESOLUTION DECLARING THE SUPPLEMENTAL BUDGET NO. 01 FOR CY 2020 OF BARANGAY NAVALUAN, MANGALDAN, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF ONE HUNDRED SEVENTY THOUSAND PESOS (P170,000.00) OPERATIVE IN ITS ENTIRETY.
