
RESOLUTION NO. 2020 – 148

RESOLUTION DECLARING THE SUPPLEMENTAL BUDGET
NO. 01 FOR CY 2020 OF BARANGAY NAVALUAN,
MANGALDAN, PANGASINAN INVOLVING A TOTAL
APPROPRIATION OF ONE HUNDRED SEVENTY
THOUSAND PESOS (P170,000.00) OPERATIVE IN ITS
ENTIRETY.

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local
Government Code of 1991, the Sangguniang Bayan of Mangaldan as a Legislative
Body of the Municipality is empowered to review Ordinances authorizing annual or
supplemental appropriations of Barangays in the manner prescribed by law;

WHEREAS, the Barangay Council of Navaluan, Mangaldan, Pangasinan

WHEREAS, the Committee on Appropriation and the Committee on Laws
and Ordinances of the Sangguniang Bayan made an initial review and study on the


