RESOLUTION NO. 2020 - 149

RESOLUTION ON THE MOTION FOR RECONSIDERATION DATED FEBRUARY 11, 2020 FILED BY THE LOCAL GOVERNMENT UNIT OF POBLACION, MANGALDAN, PANGASINAN.

WHEREAS, the Barangay Poblacion represented by its elected officials led by Punong Barangay Melinda "Tonet" Morillo has filed a Motion for Reconsideration following the twin denials of their proposed Revenue Code;

WHEREAS, the Sangguniang Bayan of Mangaldan has allowed the Motion to be heard on December 10, 2019 and which was attended by the barangay officials before the Hon. Presiding Officer Vice Mayor PEDRO "JOJO" A. SURDILLA, JR.;

WHEREAS, during the hearing of the motion, Resolution No. 2020-12 issued by the Sangguniang Bayan which denied the proposed Revenue Code submitted by Brgy. Poblacion on December 26, 2019 was read out in the open upon motion of Councilor Joel C. Meneses;

WHEREAS, it became evident that the issues raised in this Motion for Reconsideration were already threshed out in Resolution No. 2020-12;

WHEREAS, the proposed Revenue Code submitted on December 26, 2019 contained new provisions on paid parking not found in the Revenue Code previously submitted to the Sangguniang Bayan on December 3, 2019;

WHEREAS, the new proposed Revenue Code still contained provisions on the payments for the issuance of Certification to File Lupon, building permit fees and the levying of taxes of businesses exceeding the Php. 50,000.00 gross annual revenue which were already previously denied by the Sangguniang Bayan for the reasons afore-cited;

WHEREAS, it was admitted by the PB Melinda “Tonet” Morillo that there was public hearing made on the proposed Revenue Code submitted on December 26, 2020;

WHEREFORE, premises considered, after an exhaustive deliberation by all the members of the Sangguniang Bayan during their session last May 15, 2020 the instant Motion for Reconsideration is hereby denied as it is bereft of merit.

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan acted on the Motion for Reconsideration dated February 11, 2020 filed by the Local Government Unit of Poblacion, Mangaldan, Pangasinan;

RESOLVED FURTHER, that copies of this resolution be furnished the Sangguniang Barangay of Poblacion through Punong Barangay Melinda P. Morillo, the MLGOO, Mrs. Romarie P. Soriano, the Commission on Audit through Mrs. Marina P. De Guzman, Audit Team Leader, the Office of the Municipal Mayor, Hon. Mary Marilyn DG. Lambino and all other authorities concerned for their information and favorable action.
