RESOLUTION NO. 2020 – 150

RESOLUTION DISMISSING ADMINISTRATIVE CASE NO.
2020-01 FOR GROSS NEGLECT OF DUTY AGAINST
PUNONG BARANGAY ARNOLFO A. MUYANO AND
BARANGAY TREASURER EUGENE P. FLORES OF
BARANGAY BARI, MANGALDAN, PANGASINAN FILED
BY ALL BARANGAY TANODS, BARANGAY HEALTH
WORKERS AND BARANGAY UTILITY WORKERS OF
BARANGAY BARI, MANGALDAN, PANGASINAN.

WHEREAS, separate complaints dated January 22, 2020 for Gross Neglect
of Duty (Adm. Case No. 2020-01) and Dishonesty and Grave Misconduct (Adm.
Case No. 2020-02) were filed before this body on January 23, 2020 by Barangay
Tanods, Barangay Health Workers, and Barangay Utility Workers of Bari, et al.
and Barangay Kgd. Hadji Ali S. Otero, et.al respectively against Respondents
Punong Barangay Arnolfo A. Muyano and Barangay Treasurer Eugene P. Flores;

WHEREAS, with the Sangguniang Bayan acting en banc, they conducted
Committee Hearing on February 14, 2020 and decided to acquire jurisdiction over
the cases at hand and right then and there granted the MOTION FOR EXTENSION
OF TIME TO FILE ANSWER which was filed by the Respondents. Relatively, on

the same date of February 14, 2020, they issued a JOINT RESOLUTION which PREVENTIVELY SUSPENDED the respondents for sixty (60) days;

WHEREAS, on March 13, 2020, a Preliminary and Pre-Trial Conference was conducted. Accordingly, the complainants in Administrative Case No.2020-01 were asked if they intend to secure the services of a counsel to represent them and if they are still interested to prosecute the case against the respondents to which complainant Leonora Pasaoa, who introduced herself as the head of the Barangay Health Workers (BHW) of Barangay Bari, verbally answered in Pangasinan dialect "*Nu nayagyari, agmi la gabay so nadamay ta agmi antay ibaga mi.*" (If it is possible, we no longer want to be involved because we do not know what to say). Another complainant in the person of Rosalinda Quinto, also a BHW, added that their respective salaries have been paid by the respondents, hence, they are no longer interested in proceeding with the case;

WHEREAS, with the foregoing manifestation of the complainants, Atty. Cerdan orally moved for the dismissal of the case on the ground of lack of interest to prosecute. The motion is now deemed submitted for resolution;

WHEREAS, in view of the oral manifestation of the complainants that they are no longer interested in prosecuting the case against the respondents, Administrative Case No. 2020-01 is hereby DISMISSED without prejudice. Without the participation of the complainants, the guilt or liability of the respondents in the instant administrative case cannot be proved;

WHEREFORE on motion duly seconded by all the remaining members present:

RESOLVED as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan dismisses Administrative Case No. 2020-01 for Gross Neglect of Duty Against Punong Barangay Arnolfo A. Muyano and Barangay Treasurer Eugene P. Flores of Barangay Bari, Mangaldan, Pangasinan filed by all Barangay Tanods, Barangay Health Workers and Barangay Utility Workers of Barangay Bari, Mangaldan, Pangasinan;

RESOLVED FURTHER, that copies of this resolution be furnished the both parties, the MLGOO, Mrs. Romarie P. Soriano, the Commission on Audit through Mrs. Marina P. De Guzman, Audit Team Leader, the Office of the Municipal Mayor, Hon. Mary Marilyn DG. Lambino and all other authorities concerned for their information and favorable action.


