RESOLUTION NO. <u>2020 – 156</u>

RESOLUTION AUTHORIZING THE 2020 ANNUAL BUDGET OF BARANGAY MACAYUG IN THE AMOUNT OF THREE MILLION THREE HUNDRED ONE THOUSAND EIGHT HUNDRED SEVENTY SEVEN PESOS AND 37/100 (P3,301,877.37) OPERATIVE FOR THEIR OPERATIONS COVERING THE FISCAL YEAR 2020 AS CONTAINED IN THEIR APPROPRIATION ORDINANCE DULY APPROVED BY THEIR SANGGUNIANG BARANGAY.

WHEREAS, pursuant to Article II, Section 333 of the Local Government Code of 1991, the Sangguniang Bayan is empowered to review the barangay ordinance authorizing the annual appropriations in order to ensure that the provisions pertinent therein are complied with;

WHEREAS, the barangays through the Punong Barangay/Barangay Treasurer submitted to the Sangguniang Bayan office their barangay budget to be reviewed, deliberated and authorized by the sanggunian if it is compliant and in conformity with the budgetary requirements, rules and regulations;

WHEREAS, after careful study, review, discussion and deliberation of all items of the programmed expenditures by the Local Finance Committee headed by

the Municipal Budget Officer and thoroughly reviewed by the Sangguniang Bayan Committee on Budget, Finance and Appropriation, the same were found to be in accordance with the existing budgetary regulations and is within the conferred powers of the sangguniang barangay to enact;

WHEREFORE, on motion of Councilor Atty. Joseph Emmanuel B. Cera duly seconded by all the remaining members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan authorizes the 2020 Annual Budget of Barangay Macayug in the amount of Three Million Three Hundred One Thousand Eight Hundred Seventy Seven Pesos and 37/100 (P3,301,877.37) operative for their operations covering the Fiscal Year 2020 as contained in their Appropriation Ordinance duly approved by their Sangguniang Barangay;
