RESOLUTION NO. 2020 – 157

RESOLUTION AUTHORIZING HONORABLE MAYOR
MARY MARILYN DG. LAMBINO, REPRESENTING THE
LOCAL GOVERNMENT UNIT OF MANGALDAN,
PANGASINAN TO ENTER INTO A MEMORANDUM OF
AGREEMENT (MOA) WITH GOLDEN SUCCESS HOTEL
THRU ITS OWNER OR ITS DULY AUTHORIZED
REPRESENTATIVE FOR THE UTILIZATION OF THE
GOLDEN SUCCESS HOTEL FACILITIES AS A TEMPORARY
QUARANTINE OR ISOLATION FACILITY OF THE LGU IN
RELATION TO THE COVID-19 OUTBREAK.

WHEREAS, Article II, Section 15 of the 1987 Philippine Constitution
Declares as one of the State Policies to protect and promote the right to health of
the people and instill health consciousness among them;

WHEREAS, various Memorandum Circulars and Advisories were issued by
the Department of Interior and Local Government where the emphasis in promoting
the health and safety of their residents, maintaining peace and order and preserving
the comfort and convenience of their inhabitants is placed on the role of the
Municipal Mayor and Punong Barangay;

WHEREAS, one of the thrusts of the Local Government Unit of Mangaldan, Pangasinan is to provide the urgent and basic services to the people during time of calamities and emergencies. Accordingly, the local administration is not remiss in its duties and responsibilities to effect compassion to its constituents by providing them with adequate assistance and basic service facilities during this time of distresses.

WHEREAS, in compliance to the aforementioned directives, every local government unit in the Philippines has its own style of governance so as to efficiently handle the worsening situation of this COVID-19. Accordingly, the Local Chief Executive is bent on renting the facilities of Golden Success Hotel which will serve as a temporary quarantine or isolation facility or area for COVID-19 related patients;

WHEREAS, pursuant to Article 87 (b) (vi) of the Rules and Regulations Implementing the Local Government code of 1991, the Municipal Mayor upon authorization by the Sangguniang Bayan, represents the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREFORE, on joint motion of Councilor Atty. Joseph Emmanuel B. Cera, Councilor Atty. Fernando Juan A. Cabrera and Councilor Christopher G. Romero duly seconded by all the remaining members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan authorizes Honorable Mayor Mary Marilyn DG. Lambino, representing the Local Government Unit of Mangaldan, Pangasinan to enter into a Memorandum of Agreement (MOA) with Golden Success Hotel thru its owner or its duly authorized representative for the utilization of the Golden Success Hotel Facilities as a temporary quarantine or isolation facility of the LGU in relation to the COVID-19 outbreak;

RESOLVED FURTHER, that copies of this resolution be furnished the Golden Success Hotel through the Authorized Representative, the MLGOO, Mrs. Romarie P. Soriano, the Commission on Audit through Mrs. Marina P. De Guzman, Audit Team Leader, the Office of the Municipal Mayor, Hon. Mary Marilyn DG. Lambino and all other authorities concerned for their information and favorable action.


