RESOLUTION AUTHORIZING HON. MARY MARILYN DG. LAMBINO, MUNICIPAL MAYOR AND MRS. MARIA ALICIA C. MEJIA, ADMINISTRATIVE OFFICER V (CASHIER III), SG-18, DESIGNATED ACTING MUNICIPAL TREASURER, TO BE THE OFFICIAL AND AUTHORIZED SIGNATORIES OF ALL BANK/BUSINESS TRANSACTIONS OF THE LOCAL GOVERNMENT UNIT OF MANGALDAN AT THE LAND BANK OF THE PHILIPPINES (LBP) MANGALDAN BRANCH, THE DEPOSITORY BANK OF THE LGU EFFECTIVE MARCH 30, 2020.

WHEREAS, the Sangguniang Bayan is in receipt of an endorsement from the Office of the Municipal Mayor for the passage of a resolution, Authorizing Mrs. Maria Alicia C. Mejia, Administrative Officer V (Cashier III), SG-18, designated Acting Municipal Treasurer of the Local Government Unit of Mangaldan, Pangasinan as one of the official and authorized signatories in all official financial transactions including bank institutions of the Municipality effective March 30, 2020;

WHEREAS, the Land Bank of the Philippines (LBP) Mangaldan Branch is one of the depository banks of the Local Government Unit of Mangaldan, Pangasinan;

WHEREAS, as provided for by the pertinent provisions of R.A. 7160, otherwise known as the Local Government Code of 1991, the Local Government Units must designate and authorize the new set of signatories in all and any Depository and Lending Institutions servicing the LGU for the smooth and proper governance of the LGU and its inhabitants;

WHEREAS, the sangguniang bayan is empowered by the local government code of 1991 to authorize the Municipal Mayor, the Municipal Vice Mayor and the Municipal Treasurer as signatories for all bank/business transactions;

WHEREFORE, on motion of Councilor Atty. Fernando Juan A. Cabrera duly seconded by all the remaining members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan authorizes Hon. Mary Marilyn DG. Lambino, Municipal Mayor and Mrs. Maria Alicia C. Mejia, Administrative Officer V (Cashier III), SG-18, Designated Acting Municipal Treasurer, to be the official and authorized signatories of all bank/business transactions of the Local Government Unit of Mangaldan at the Land Bank of the Philippines (LBP) Mangaldan Branch, the depository bank of the LGU effective March 30, 2020;


