RESOLUTION AUTHORIZING HON. ATTY. PEDRO A. SURDILLA, JR., MUNICIPAL VICE MAYOR AND PRESIDING OFFICER AND MRS. MARIA ALICIA C. MEJIA, ADMINISTRATIVE OFFICER V (CASHIER III), SG-18, DESIGNATED ACTING MUNICIPAL TREASURER, TO BE THE OFFICIAL AND AUTHORIZED SIGNATORIES FOR ALL DEPOSITS AND OTHER RELATED BANK TRANSACTIONS AT THE POSTAL BANK ON ALL EXPENDITURES APPROPRIATED FOR THE OPERATION OF THE SANGGUNIANG BAYAN AND THE OFFICE OF THE SANGGUNIANG BAYAN SECRETARY OF THE LOCAL GOVERNMENT UNIT OF MANGALDAN, PANGASINAN EFFECTIVE MARCH 30, 2020.

WHEREAS, the Sangguniang Bayan is in receipt of an endorsement from the Office of the Municipal Mayor for the passage of a resolution, Authorizing Mrs. Maria Alicia C. Mejia, Administrative Officer V (Cashier III), SG-18, designated Acting Municipal Treasurer of the Local Government Unit of Mangaldan, Pangasinan as one of the official and authorized signatories in all official financial transactions including bank institutions of the Municipality effective March 30, 2020;

WHEREAS, the Postal Bank is one of the depository banks of the Local Government Unit of Mangaldan, Pangasinan;

WHEREAS, Section 445 (1) of the Local Government Code of 1991 mandates that the Vice Mayor shall be the Presiding Officer of the Sangguniang Bayan and shall sign all warrants drawn on the Municipal Treasury on all expenditures appropriated for the operation of the Sangguniang Bayan;

WHEREAS, the Vice Mayor/Presiding Officer being the head of the local legislative department is authorized to sign all vouchers, all checks/warrants for all expenditures appropriated under the Office of the Sangguniang Bayan including the Sangguniang Bayan Secretariat;

WHEREFORE, on motion of Councilor Atty. Fernando Juan A. Cabrera duly seconded by all the remaining members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan authorizes Hon. Atty. Pedro A. Surdilla, Jr., Municipal Vice Mayor and Presiding Officer and Mrs. Maria Alicia C. Mejia, Administrative Officer V (Cashier III), SG-18, Designated Acting Municipal Treasurer, to be the official and authorized signatories for all deposits and other related bank transactions at the Postal Bank on all expenditures appropriated for the operation of the Sangguniang Bayan and the Office of the Sangguniang Bayan Secretary of the Local Government Unit of Mangaldan, Pangasinan effective March 30, 2020;

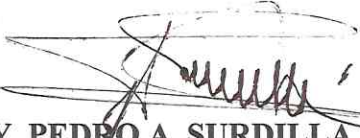
