RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HONORABLE MARY MARILYN DG. LAMBINO TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) OR SIMILAR CONTRACT WITH THE DEPARTMENT OF **DEVELOPMENT** (DSWD), AND SOCIAL WELFARE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE), DEPARTMENT OF TRADE AND INDUSTRY (DTI), OR (DA) FOR AGRICULTURE DEPARTMENT OF PROVISION OF SOCIAL AMELIORATION MEASURES TO AREAS UNDER ENHANCED COMMUNITY QUARANTINE.

WHEREAS, President Rodrigo Roa Duterte declared an Enhance Community Quarantine in the entirety of Luzon last March 17, 2020 due to increase threat of COVID-19 to Code Red Sublevel 2;

WHEREAS, the declaration of community quarantine and the imposition of Stringent Social Distancing Measures affected the population's mobility as ingress and egress to and from the Municipality have been restricted, causing the struggle of Filipino families for economic survival;

WHEREAS, the Bayanihan to Heal As One Act empowers the National Government to provide an emergency subsidy to eighteen (18) million low-income families for basic food, medicine and toiletries;

WHEREAS, the Department of Social Welfare and Development (DSWD), in coordination and collaboration with other national agencies such as but not limited to, Department of Labor and Employment (DOLE), Department of Trade and Industry (DTI), Department of Agricutlure (DA), Department of Finance (DOF), Department of Budget and Management (DBM) and Department of Interior and Local Government (DILG), shall implement social protection programs, projects and services to mitigate the effects of the declaration on the economic, physical and psychological well-being of the most vulnerable sectors;

WHEREAS, this intensified government response on the implementation of social amelioration measures by concerned agencies shall ensure mobilization of the necessary resources for the provision of urgent and appropriate services and assistance;

WHEREAS, Joint Memorandum Circular No. 1, Series of 2020 by the DILG, DBM, DSWD, DA, DTI and DOF, prescribed the special guidelines on the provision of social amelioration measures by concerned national government agencies and its implementation to most vulnerable sectors;

WHEREAS, Local Government Units are mandated to provide assistance to the implementation of this Social Amelioration Measures as provided in Item 9.2 of JMC No. 1, 2020;

WHEREAS, there is a need for the Honorable Mayor to authorized by the Sangguniang Bayan to enter into Memorandum of Agreement (MOA) with concerned agencies for the proper implementation of the social amelioration programs and mitigate the effects of COVID-19 to vulnerable sectors;

WHEREAS, this Honorable August Body after due consideration and satisfied that the said measure if for the interest of the public service and would enhance the immediate delivery of basic services to our affected people, is convinced of the merit and wisdom of the purpose of which authority is hereby sought by the Honorable Mayor;

WHEREFORE, on joint motion of Councilor Atty. Joseph Emmanuel B. Cera, Councilor Atty. Fernando Juan A. Cabrera and Councilor Christopher G. Romero duly seconded by all the remaining members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan AUTHORIZES the Honorable Mayor Mary Marilyn DG. Lambino to enter into a Memorandum of Agreement (MOA) or of similar contract with the DSWD, DOLE, DTI or DA as the case maybe, for the implementation of the social amelioration measures under The Bayanihan to Heal As One Act and as prescribed by Joint Memorandum Circular No. 1, Series of 2020 of DILG, DBM, DSWD, DA, DTI and DOF;
