RESOLUTION NO. 2020 – 89

AN EN BANC RESOLUTION CALLING FOR AN EXTENSION
ON THE PAYMENT OF REALTY TAXES UNTIL JUNE 2020.

WHEREAS, the REVENUE CODE OF MANGALDAN is the lifeblood of the municipality fueling its growth;

WHEREAS, the national government through President Rodrigo Duterte imposed enhanced community quarantine throughout the island of Luzon in order to contain the corona virus which causes COVID-19;

WHEREAS, for a great majority of our people, the essentials of food, shelter and clothing takes precedence over all other financial considerations as money has become short as a result of lost job opportunities, non-essential businesses being temporarily shuttered and daily-wage earners unable to report to work because there is no work;

WHEREAS, the enhanced community quarantine started on March 15, 2020 and is supposed to last until April 12, 2020 but there are groups calling for an extension of such;



WHEREAS, the Local Government Unit of Mangaldan through its Revenue Code has imposed the deadline for the payment of realty taxes on March 31, 2020. But there is a strong public clamor from our people that such payment shall be extended preferably until June 30, 2020;

WHEREAS, there is a need to heed this urgent request as we do our part to lessen the financial burden of our community;

WHEREFORE, on motion of Councilor Atty. Joseph Emmanuel B. Cera duly seconded by all the remaining members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan calls for an Extension on the Payment of Realty Taxes until June 2020;

RESOLVED FURTHER, that copies of this resolution be furnished the Acting Municipal Treasurer, Mrs. Maria Alicia C. Mejia, the MLGOO, Mrs. Romarie P. Soriano, the Commission on Audit through Mrs. Marina P. De Guzman, Audit Team Leader, the Office of the Municipal Mayor, Hon. Mary Marilyn DG. Lambino and all other authorities concerned for their information and favorable action.


