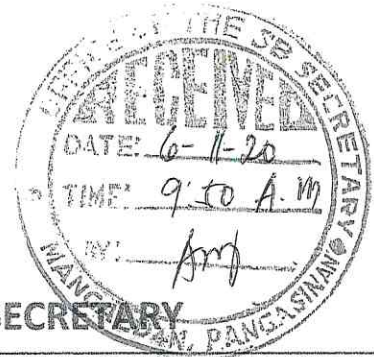

RESOLUTION NO. 409-2020

APPROVING RESOLUTION NO. 2020-92 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED "APPROVING AND ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN (AIP) NO. 3, CY 2020 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Resolution No. 2020-20 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council – Executive Committee of Mangaldan, Pangasinan prepared the Supplemental Annual Investment Program (SAIP) No. 3 for CY 2020. This was endorsed by the Council, through MDC Resolution No. 3, Series of 2020 dated April 8, 2020 to the Sangguniang Bayan for approval;

WHEREAS, the Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 2020-92 dated April 8, 2020;

WHEREAS, said Supplemental AIP No. 3, CY 2020, which has a total investment requirement of P20,160,164.00, is appropriated for the procurement of Personal Protective Equipment (PPEs); provision of food assistance and other relief goods; and procurement of equipment, reagents and kits for COVID-19 testing and other necessary COVID-19 related PPAs and expenses of the LGU;

WHEREAS, funding for the Supplemental AIP will be sourced from the Bayanihan Grant to Cities and Municipalities (as per Local Budget Circular No. 125, Series of 2020) as embodied in their Supplemental Budget No. 3, FY 2020, and approved by their Sangguniang Bayan through Appropriation Ordinance No. 2020-03 dated April 8, 2020;
