RESOLUTION NO. 2020 – 92

RESOLUTION APPROVING AND ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN (AIP) NO. 3, CY 2020 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN.

WHEREAS, Article II, Section 15 of the 1987 Philippine Constitution declares as one of the State Policies to protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, His Excellency President Rodrigo Roa Duterte issued Proclamation Nos. 922 and 929, "Declaring a State of Public Health Emergency throughout the Philippines" and "Declaring a State of Calamity throughout the Philippines due to Corona Virus Disease 2019", respectively, in connection with the onslaught of Corona Virus Disease (COVID-19) which is now considered by World Health Organization (WHO) as pandemic;

WHEREAS, R.A. 11469, otherwise known as the Bayanihan to Heal as One ACT granted the President of the Republic of the Philippines the power to adopt various temporary emergency measures to respond to the crunches brought about by this monstrous disease. Accordingly, a Bayanihan Grant to Cities and

Municipalities will be released to all LGU's from city to municipal level to boost their capacity in immediately responding to the COVID-19 emergency;

WHEREAS, the Municipal Development Council Executive Committee convened a meeting today, April 8, 2020 and have discussed matters pertaining to the pressing problems on Corona Virus Disease 2019 (COVID-19) and further deliberated on the utilization of the allocation from the Bayanihan Grant to the Municipality of Mangaldan, Pangasinan in the amount of Twenty Million One Hundred Sixty Thousand and One Hundred Sixty-Four Pesos only (P 20,160,164.00). Corollary to this, the same Municipal Development Council Executive Committee passed and approved MDC Resolution No. 3, Series of 2020, *"Strongly Endorsing the Annual Investment Program (AIP) CY 2020 Supplemental No. 3 for the Programs/Project/Activities needing priority to address COVID-19 situation in the Municipality of Mangaldan, Pangasinan"*. This shall be appropriated for the identified Priority Programs/Projects/Activities in the AIP 2020 Supplemental No. 3 to address COVID-19 situation, as follows: 1) Procurement of Personal Protective Equipment – P660,164.00; 2) Food Assistance and other Relief Goods – P15,000,000.00; and 3) Procurement of equipment, reagents, and kits for COVID-19 related PPA's and expenses – P4,500,000.00;

WHEREAS, considering the urgency of the programs, projects, and activities embodied in the Plan and understood to be in conformity with the thrust of the local government unit contributing to the welfare of the people of Mangaldan, Pangasinan, the members of the Honorable August Body deemed it fitting and proper to adopt the said measure;

WHEREFORE, on motion of Councilor Atty. Joseph Emmanuel B. Cera duly seconded by all the remaining members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan approves and adopts the Supplemental Annual Investment Plan (AIP) No. 3, CY 2020 of the Municipality of Mangaldan, Pangasinan;

Petonio, the Acting Municipal Treasurer, Mrs. Maria Alicia C. Mejia, the Municipal Accountant, Mrs. Josie G. Bulatao, the Office of the Municipal Mayor, Hon. Mary Marilyn DG. 
