RESOLUTION NO. <u>2020 – 94</u>

RESOLUTION ADOPTING FOR IMPLEMENTATION, PROVINCIAL ORDINANCE NO. 235 – 2020, "AN ORDINANCE REQUIRING THE MANDATORY WEARING OF FACE MASKS BY ALL PERSONS IN PUBLIC PLACES WITHIN THE TERRITORIAL JURISDICTION OF THE PROVINCE OF PANGASINAN DURING THE PERIOD OF ENHANCED COMMUNITY QUARANTINE AND FOR ANY EXTENSION THEREOF.

WHEREAS, Article II, Section 15 of the 1987 Philippine Constitution Declares as one of the State Policies to protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, His Excellency President Rodrigo Roa Duterte issued Proclamation Nos. 922 and 929, "Declaring a State of Public Health Emergency throughout the Philippines" and Declaring State of Calamity throughout the Philippines due to Corona Virus Disease 2019", respectively in connection with the onslaught of Corona Virus Disease 2019 (COVID-19) which is now considered by World Health Organization (WHO) as pandemic;

WHEREAS, various Memorandum Circulars and Advisories were issued by the Department of interior and local Government where the emphasis in promoting the health and safety of their residents, maintaining peace and order and preserving the comfort and convenience of their inhabitants is placed on the role of the Local Government Units;

WHEREAS, wearing of face masks is a public health measure people should take to reduce if not totally eradicate the spread of COVID-19 in addition to social distancing, frequent hand cleaning and other everyday preventive actions or measures;

WHEREAS, wearing of face mask will be mandatory for everyone within the territorial jurisdiction of Mangaldan whenever they are on public places regardless of having symptoms or not;

WHEREAS, every Local Government Units are mandated to take precautionary measures supported by appropriate legislations so as to have force and effect of the law for its effective implementation;

WHEREFORE, on motion duly seconded by all the remaining members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan adopts for implementation, Provincial Ordinance No. 235 – 2020, "An Ordinance Requiring the Mandatory Wearing of Face Masks by all Persons in Public Places within the Territorial Jurisdiction of the Province of Pangasinan during the period of Enhanced Community Quarantine and for any extension thereof;

Wacnag, Chief of Police, the Municipal Health Office through Dr. Larry B. Sarito, and all other authorities concerned for their information and favorable action.
