RESOLUTION STRONGLY ENDORSING AND SUPPORTING EXECUTIVE ORDER NOS. 2020-L-026 AND 2020-L-027, RE: "AN ORDER REQUIRING THE MANDATORY WEARING OF MASKS IN PUBLIC PLACES IN THE MUNICIPALITY OF PANGASINAN", AND "AN **ORDER** MANGALDAN, DISCRIMINATORY **ACTS** ON HEALTH PROHIBITING WORKERS, OFW's, COVID-19 CASES, PUI's AND PUM's IN THE MUNICIPALITY OF MANGALDAN, PANGASINAN", RESPECTIVELY BY THE LOCAL CHIEF EXECUTIVE, HON. MARY MARILYN DG. LAMBINO.

WHEREAS, Article 2, Section 15 of the 1987 Philippine Constitution declares as one of the State policies to protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, the same 1987 Philippine Constitution provides that every person has the right to live, liberty and security of person and privacy, and the right to be free from discrimination, and further ensures the dignity of every person and guarantees full respect for human rights;

WHEREAS, His Excellency Rodrigo Roa Duterte, issued Proclamation Nos. 922 and 929 "DECLARING A STATE OF PUBLIC HEALTH EMERGENCY

MERGENCI

THROUGHOUT THE PHILIPPINES" and "DECLARING STATE OF CALAMITY THROUGHOUT THE PHILIPPINES DUE TO CORONA VIRUS DISEASE 2019", respectively in connection with the onslaught of Corona Virus Disease 2019 (COVID-19) which is now considered by World Health Organization (WHO) as pandemic;

WHEREAS, the COVID-19 pandemic brought serious threat across all nations worldwide that even resulted to the loss of thousands of lives. Accordingly, health workers are obliged by authorities to render their services amidst this crisis brought about by COVID-19 and they have been day by day facing exceptional challenges during this plague;
