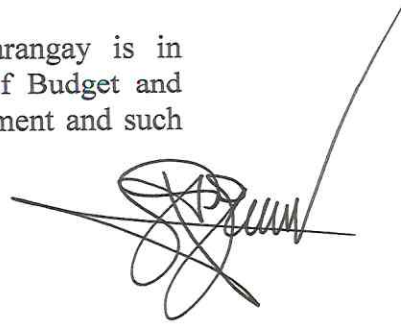
RESOLUTION NO. 2020 – 96

WHEREAS, the Sangguniang Bayan, after final evaluation, finds the subject resolution in order;

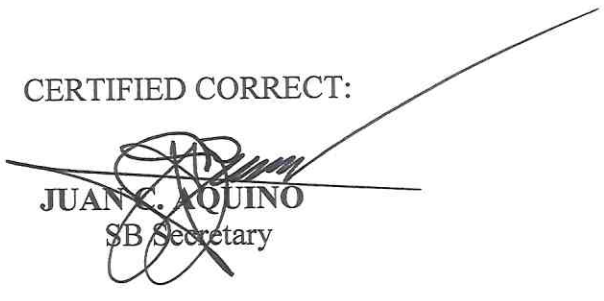
WHEREFORE, on motion of Councilor Atty. Joseph Emmanuel B. Cera duly seconded by all the remaining members present:

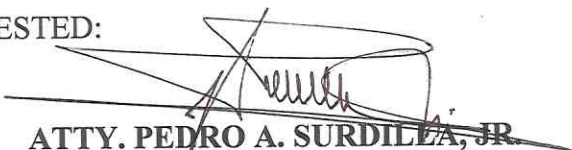
