**DECLARING MUNICIPAL ORDINANCE NO. 2022-06 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING SECTION 1 (A), SECTION 2 (A), AND SECTION 3(A) OF MUNICIPAL ORDINANCE NO. 2021-23 ENTITLED "AN ORDINANCE CREATING ADDITIONAL PLANTILLA POSITIONS UNDER DIFFERENT OFFICES IN THE MUNICIPALITY OF MANGALDAN, PANGASINAN AND APPROPRIATING FUNDS THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Ordinance No. 2022-06 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Local Finance Committee of the Province and the Human Resource Management and Development Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 12 (a) (b) of RA 10121( Philippine Disaster Risk Reduction and Management Act of 2010), Sections 76 and 447 (a) (1) (viii) of RA 7160, Section 83 of RA 10352 (General Appropriations Act FY 2013, and NDRRMC-DILG-DBM-CSC Joint Memorandum Circular No. 2014-1 dated April 4, 2014;


