MUNICIPAL ORDINANCE NO. 2022 - 02


AN ORDINANCE APPROVING THE RECLASSIFICATION OF LAND SITUATED AT BARANGAY GUILIG, MUNICIPALITY OF MANGALDAN, PANGASINAN.

WHEREAS, pursuant to Section 447 (2)(viii) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Bayan, as the legislative body, has the power to reclassify land within the jurisdiction of the Municipality, subject to the pertinent provision of this Code;

WHEREAS, Section 20 of the same Local Government Code provides for the authority of the Sangguniang Bayan to authorize the reclassification of agricultural lands, and provide the manner of their utilization and disposition of land when it ceases to be economically feasible for agricultural purposes and determined to have more substantial greater economic value for residential, commercial or industrial purposes;

WHEREAS, the Office of the Municipal Mayor has endorsed to the Sangguniang Bayan the reclassification of parcels of land covered under Tax Declaration Nos. 015 36642, 015 31629, 015 34008, 015 35003 and 015 53111 all located at Barangay Guilig, Mangaldan, Pangasinan as a result of the Municipal

SB Ordinance No. 2022 – 02 February 10, 2022

Development Council Executive Committee (MDC-EXECOM) meeting or November 16, 2021;

WHEREAS, the subject land shall be strictly utilized in accordance with the Municipal Zoning Ordinance of Mangaldan and other applicable law, rules and regulation;

NOW THEREFORE, be it ordained by the Sangguniang Bayan of Mangaldan, Pangasinan that:

Section 1. TITLE. - This Ordinance shall be known as "An Ordinance approving the reclassification of land situated at Barangay Guilig, Municipality of Mangaldan, Pangasinan".

Section 2. SCOPE. - This Ordinance covers all the parcel of land covered under tax declaration numbers 015 36642, 015 31629, 015 74008, 015 35003 and 015 53111 all located at Barangay Guilig, Mangaldan, Pangasinan, subject to the limitation prescribed in this Ordinance and other related laws of the Republic.

Section 3. RECLASSIFICATION OF AGRICULTURAL LANDS TO COMMERCIAL CLASSIFICATION. - All parcel of agricultural lands which are mentioned in the next preceding section shall be reclassified into Commercial Classification taking into consideration the following conditions, to wit:

- a. The land ceases to be economically feasible and sound for the agricultural purposes as determined by the Department of Agriculture.
- b. The land shall have substantially greater economic value for the residential, commercial, or industrial purposes as determined by the Sanggunian.

Section 4. SEPARABILITY CLAUSE. – If, for any reason, any section or provision of this Ordinance or any part thereof, is declared invalid or unconstitutional, the other provision not affected, thereby shall continue in full force and effect.

Section 5. EFFECTIVITY. - This Ordinance shall take effect immediately upon approval.
