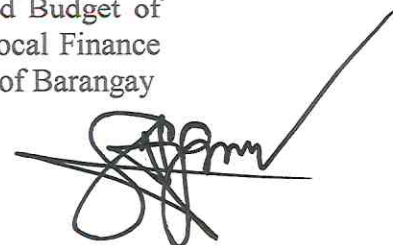
RESOLUTION NO. 2022 – 69

RESOLUTION AUTHORIZING THE 2022 ANNUAL BUDGET OF
BARANGAY BANAANG IN THE AMOUNT OF EIGHT
MILLION FIVE HUNDRED FORTY THREE THOUSAND
FOUR HUNDRED NINETY FIVE PESOS (P8,543,495.00)
OPERATIVE FOR THEIR OPERATIONS COVERING THE
FISCAL YEAR 2022 AS CONTAINED IN THEIR
APPROPRIATION ORDINANCE DULY APPROVED BY THEIR
SANGGUNIANG BARANGAY.

WHEREAS, forwarded to this body is Annual Budget for Fiscal Year 2022

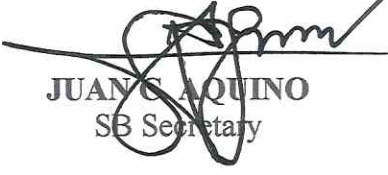
WHEREFORE, on Councilor Atty. Fernando Juan A. Cabrera duly seconded by other members present:

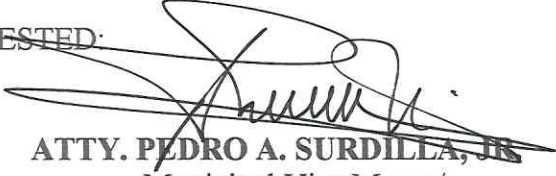
