
RESOLUTION NO. 2022 – 71

RESOLUTION AUTHORIZING THE 2022 ANNUAL BUDGET OF
BARANGAY INLAMBO IN THE AMOUNT OF THREE
MILLION NINE HUNDRED THIRTEEN THOUSAND ONE
HUNDRED THIRTY TWO PESOS AND 46/100 (P3,913,132.46)
OPERATIVE FOR THEIR OPERATIONS COVERING THE
FISCAL YEAR 2022 AS CONTAINED IN THEIR
APPROPRIATION ORDINANCE DULY APPROVED BY THEIR
SANGGUNIANG BARANGAY.

WHEREAS, forwarded to this body is Annual Budget for Fiscal Year 2022

WHEREFORE, on Councilor Atty. Fernando Juan A. Cabrera duly seconded by other members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan authorizes the 2022 Annual Budget of Barangay Inlambo in the amount of Three Million Nine Hundred Thirteen Thousand One Hundred Thirty Two Pesos and 46/100 (P3,913,132.46) operative for their operations covering the Fiscal Year 2022 as contained in their Appropriation Ordinance duly approved by their Sangguniang Barangay;
