## RESOLUTION NO. <u>2022 – 72</u>

RESOLUTION AMENDING RESOLUTION NO. 2021-151 TO INCORPORATE PROVISONS PERTINENT TO LANDBANK'S PROGRAM ON RESTORATION AND INVIGORATION PACKAGE FOR A SELF-SUFFICIENT ECONOMY TOWARDS UPGROWTH FOR LGUs (RISE-UP LGUs).

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan has passed and approved Resolution No. 2021-151, dated June 4, 2021 "Ratifying the Loan Agreement entered into by the Local Chief Executive Mayor Mary Marilyn DG. Lambino, on behalf of the Municipality of Mangaldan, Pangasinan and the Land Bank of the Philippines in the amount of One Hundred Fifty Million (P150,000,000.00) under assignment of the borrower of its IRA;

WHEREAS, the Land Bank of the Philippines introduced its recovery program on Restoration and Invigoration Package for self-Sufficient Economy towards Upgrowth for LGUs (RISE-UP LGUs) or RISE-UP LGUs which is a new lending program available by Land bank for Local Government Units (LGUs) to support them in the implementation of Economic Recovery Plan aimed in reviving the local economy;

WHEREAS, the local authority explicitly amends the provisions of the previous resolution mentioned above and collectively supply the following provisions, to wit:

- 1. Approves all previous representations, acts, warranties, and all terms and conditions of the loan.
- 2. Authorizes the assignment of the IRA and other income, revenues and collections as collateral/security to the loan obtained and declaring them to be available and not restricted by law or its obligations.
- 3. Directs the LGU Treasurer and Accountant to enter the loan in the appropriate books of the LGU.
- 4. Designate the LANDBANK as the LGU's official depository bank for IRA and major depository for its other deposits, revenue and collections which designation shall not be revoked while the loan obligations remain outstanding and directing the LGU secretary to provide a copy of this Resolution to DBM or other IRA-administering office.
- 5. Appropriate the amount for repayment in the LGU's annual budget until the loan, interest and other charges are fully paid.
- 6. Waive the confidentiality of information on investment/bank deposit.

WHEREAS, this body recognizes the importance of this initiative for efficient, and effective governance in adherence to the promotion of the general welfare of the municipality and its inhabitants as provided in Section 16 of the Local Government Code;

WHEREFORE, on joint motion of Councilor Atty. Fernando Juan A. Cabrera and Councilor Atty. Joseph Emmanuel B. Cera duly seconded by all other members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan amends Resolution No. 2021 – 151 to incorporate provisions pertinent to Land Bank's Program on Restoration and Invigoration Package for a Self-Sufficient Economy towards Upgrowth for LGUs (RISE-UP LGUs);
