RESOLUTION NO. <u>2022 – 74</u>

RESOLUTION APPROVING THE PROGRAMS, PROJECTS AND ACTIVITIES OF THE MUNICIPALITY FUNDED UNDER DBM LOCAL BUDGET MEMO NO. 84 (TOBACCO EXCISE TAX).

WHEREAS, the DBM Local Budget Memo No. 84 prescribe the guidelines on the release and utilization of the subject shares of Local Government Units, and emphasize the posting and reporting to enhance transparency and accountability;

WHEREAS, Section 444 (1)(ii) of Republic Act No. 7160 provides, the Local Chief Executive shall exercise general supervision and control over all programs, projects, services and activities of the municipal government, direct the formulation of the municipal development plan, with the assistance of the Local Development Council and upon approval thereof by the Sangguniang Bayan, implement the same;

WHEREAS, shares of beneficiary LGU shall be utilized for programs that will provide financial support for tobacco farmers, livelihood projects for the development of alternative farming system, cooperative projects to assist tobacco farmers in planting alternative crops or implementing other livelihood projects;
