RESOLUTION NO. 2022 – 76

RESOLUTION RATIFYING THE DEED OF  
TRANSFER/DONATION MADE BETWEEN THE  
MUNICIPALITY OF MANGALDAN, PANGASINAN AND  
THE DIFFERENT BARANGAY RECIPIENTS OF MOTOR  
VEHICLES FOR THE PROVISION OF SIXTEEN (16) UTILITY  
VEHICLES FOR PUBLIC USE OF THE BARANGAYS.

WHEREAS, the Office of the Municipal Mayor submitted its endorsement  
letter dated May 6, 2022, and certified WITH URGENCY and received by the  
Sangguniang Bayan Office on May 13, 2022, seeking the passage of a Resolution,  
RE: "Authorizing the Local Chief Executive, Mayor Mary Marilyn DG. Lambino  
to enter into a Deed of Donation with the different barangays of the municipality  
for the provision of Sixteen (16) utility vehicles for public use;

WHEREAS, on May 13, 2022, the Sangguniang Bayan of Mangaldan,  
Pangasinan authorized the Honorable Municipal Mayor to enter into the said Deed  
of Donation in relation to the provision of the next preceding paragraph;

WHEREAS, on May 19, 2022, the Local Chief Executive, Hon. Mary  
Marilyn DG. Lambino, representing the Local Government Unit of Mangaldan,  
Pangasinan entered into a Deed of Donation in favor of the following Barangays,

namely: Alitaya, Anolid, Banaoang, Bantayan, Buenlag, Embarcadero, Maasin, Navaluan and Tebag as beneficiaries of the said Donation/Transfer, pursuant to the provision of Section 444 (a)(b)(1)(vi) of the Local Government Code of 1991;

WHEREAS, the municipal government values its constituents, thus, provision of said vehicles to different barangays will inspire as well as to ensure their commitment in the delivery of public service to the people for a more efficient and effective governance;

WHEREAS, Section 16 of Republic Act No. 7160 of the Local Government Code, "every local government shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, an endorsement letter dated May 18, 2022, and certified WITH URGENCY was submitted and received by the Office of the Sangguniang Bayan of Mangaldan, Pangasinan on the same date of May 18, 2022 for appropriate action;

WHEREAS, the Sangguniang Bayan of Mangaldan made an in-depth discussion as to the ownership of the Local Government Unit of Mangaldan in so far as the subject vehicles are concerned. It was ascertained that all vehicles were already under the name of the municipality of Mangaldan, Pangasinan. Accordingly, the Body believes that the initiatives of the local authority are in consonance with the development thrust of the municipality for the welfare of the Barangay people;

WHEREFORE, on motion duly seconded by all the Sangguniang Bayan members:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan ratifies the Deed of Transfer/Donation made between the Municipality of Mangaldan, Pangasinan and the different Barangay recipients of Motor Vehicles for the provision of Sixteen (16) utility vehicles for public use of the barangays;

RESOLVED FURTHER, that copies of this resolution be furnished Barangays Alitaya, Anolid, Banaoang, Bantayan, Buenlag, Embarcadero, Maasin, Navaluan, and Tebag through their respective Punong Barangays, the MLGOO, Mrs. Romarie P. Soriano, the Commission on Audit through Mrs. Marina P. De Guzman, Audit Team Leader, the Office of the Municipal Mayor, Hon. Mary Marilyn DG. Lambino and all other authorities concerned for their information and favorable action.
