NOVEMBER 2020 PHYSICIAN LICENSURE EXAMINATION.

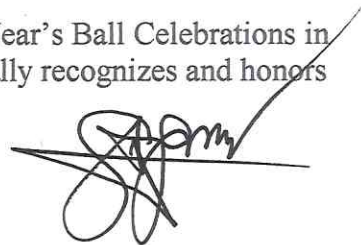
WHEREAS, the Professional Regulation Commission announced the
results of the Physician Licensure Examination (PLE) given by the Board of
Medicine in November 2020;

WHEREAS, 3,538 out of 4,704 passed the PLE with at least 80% overall
passing percentage;

WHEREAS, Dr. Clemenzar Moulic Agullana of Barangay Poblacion, the
son of Mr. Cezar and Mrs. Milagros Agullana, passed the 2020 PLE;

WHEREAS, Dr. Agullana passing the PLE brings honor not only to himself
and his family but also to the Municipality of Mangaldan. Moreover, Dr. Argullana
serves as an inspiration to the youth and students of Mangaldan aspiring to be
future physicians;

WHEREAS, as compared to pre-pandemic New Year's Ball Celebrations in
