NOVEMBER 2020 PHYSICIAN LICENSURE EXAMINATION.

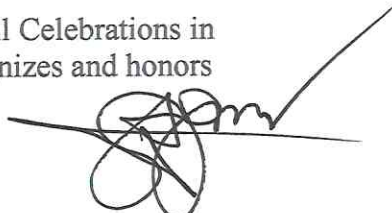
WHEREAS, the Professional Regulation Commission announced the
results of the Physician Licensure Examination (PLE) given by the Board of
Medicine in November 2020;

WHEREAS, 3,538 out of 4,704 passed the PLE with at least 80% overall
passing percentage;

WHEREAS, Dr. Lisette Verzosa Biasura of Barangay Inlambo, the
daughter of Mr. Daniel and Mrs. Letecia Biasura, passed the 2020 PLE;

WHEREAS, Dr. Biasura passing the PLE brings honor not only to herself
and her family but also to the Municipality of Mangaldan. Moreover, Dr. Biasura
serves as an inspiration to the youth and students of Mangaldan aspiring to be
future physicians;

WHEREAS, as compared to pre-pandemic New Year's Ball Celebrations in

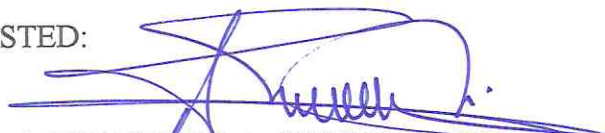
