
RESOLUTION CONGRATULATING AND COMMENDING DR. JACEL FRANCESCA DE GUZMAN DE JESUS FOR PASSING THE NOVEMBER 2020 PHYSICIAN LICENSURE EXAMINATION.

WHEREAS, the Professional Regulation Commission announced the results of the Physician Licensure Examination (PLE) given by the Board of Medicine in November 2020;

WHEREAS, 3,538 out of 4,704 passed the PLE with at least 80% overall passing percentage;

WHEREAS, Dr. Jacel Francesca De Guzman De Jesus of Barangay Guiguilonen, the daughter of Chef Jay and Mrs. Racquel De Jesus, passed the 2020 PLE;

WHEREAS, Dr. De Jesus passing the PLE brings honor not only to herself and her family but also to the Municipality of Mangaldan. Moreover, Dr. De Jesus serves as an inspiration to the youth and students of Mangaldan aspiring to be future physicians;



WHEREAS, as compared to pre-pandemic New Year's Ball Celebrations in the municipality when the Local Government Unit usually recognizes and honors board and bar passers, no such ceremony was held or conducted in the years 2020, 2021, and 2022;


