RESOLUTION NO. 2022 – 85

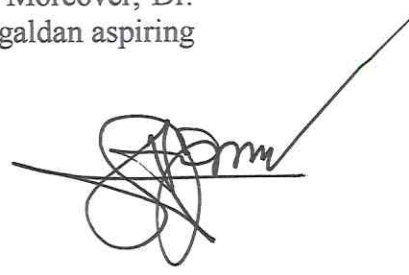
RESOLUTION CONGRATULATING AND COMMENDING

WHEREAS, the Professional Regulation Commission announced the
results of the Physician Licensure Examination (PLE) given by the Board of
Medicine in November 2020;

WHEREAS, 3,538 out of 4,704 passed the PLE with at least 80% overall
passing percentage;

WHEREAS, Dr. Raytheon Petilla Villanueva of Barangay Talogtog, the son
of Mr. Rolando and Mrs. Milagros Villanueva, passed the 2020 PLE;

WHEREAS, Dr. Villanueva passing the PLE brings honor not only to

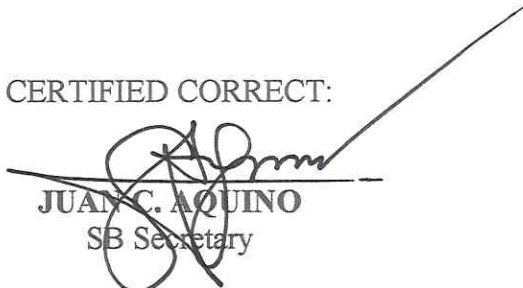
WHEREFORE, on motion of Councilor Aldrin O. Soriano duly seconded by all remaining members present:

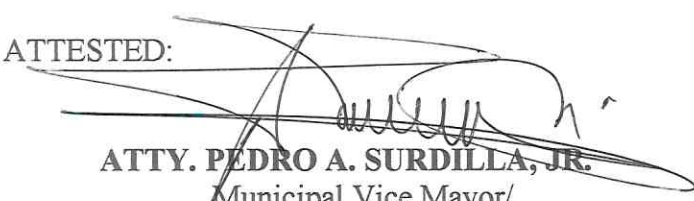
