

WHEREAS, out of 2,367 examinees, 361 passed the examination with a
passing rate of only 15.25%;

WHEREAS, Ms. Bea Viel Ventanilla of Barangay Maasin, the daughter of
Mr. Billy and Mrs. Evangeline Ventanilla, passed the 2021 CPALE;

WHEREAS, Ms. Ventanilla passing the CPALE brings honor not only to
herself and her family but to the Municipality of Mangaldan. Moreover, giving
inspiration to the youth and students of Mangaldan aspiring to be future
accountants;


